




Q5 - If you were School Library Licensure student, how familiar are you with the Standards for the 21st Century Learner?






Q9 - Statement: I feel knowledgeable of the principles involved in the organization and representation (cataloging) of recorded knowledge and information.


Q15 - Statement: I feel that the curriculum addressed the issues I expect to encounter as a professional in the field.

Q16 - Statement: Faculty members were available for advising during the advising periods.



Q17 - Statement: My competence working with current and emerging technology was




Q18 - Statement: I was provided with opportunities to collaborate with fellow students.


## Q19 - Statement: I would recommend this program to others.


Q20 - Statement: There is a sense of community among the students.


I think the reference course was excellent and gave us good practice in using different reference sources. I also found the youth programming course and young adult literature course interesting.

I feel that the curriculum was well organized which allowed students the opportunity to choose electives that (we) they found of great interest to them.

Too much time spent going over APA citations, grammar, and other aspects of "How to write a paper" - I think a graduate student should be expected to know these things (or at least figure out on his/her own time!) - much instructional time wasted on walking students through this again and again and again...

Some of the YA assigned reading literature was offensive, disgusting and should be assigned with greater consideration.

Find ways to integrate far away students into the school community.

For those of us already in or going into public libraries, I found the Master's Project to be impractical for future use. The introduction to that type of research found in the Intro to Information Science class is enough to make us familiar with the concepts but I think it would be much more practical to give students a choice in writing a paper on a research project or writing a comprehensive thesis on a particular topic of interest.

Technology topics could use a reboot. Many of the articles that are required reading for the technology classes are a decade or more old. The recent ones were about four years old. While that may be ok in some fields, it's not optimal with regard to technology. The digital librarianship class, especially, would benefit from a revised syllabus and readings.

More work with ILS systems

Allow students to express themselves in class instead of discussion boards.

The Research Methods course should continue to be a requirement, but the continuation of the course (LIS 695) should be taken soon after so as not to lose momentum of the project itself due to time lapses between semesters.

I think the program needs to be updated. Librarians and libraries (esp. academic libraries) are now expected to do more teaching, and there is only one (not always offered) course on teaching. Further, the courses that focus on technology do not really discuss integrated library systems or any really relevant technology to the field. I also think that the nature of the program should be reconsidered: a hybrid model would work better. Local students should have the option to attend an actual class while out-of-town students should be required to attend certain meeting throughout the semester.




I loved this program. It worked well with my work schedule and the teachers are very helpful.
